Bishop Aitken's Pastoral Christmas Letter - 2018

In Jesus, God "invaded" creation and heaven's goodness broke through to this earth. For the Gospel writers, it is clear that God was in a 're-claiming the whole creation' mode in the events of that first Christmas. Through Jesus, human beings were confronted with a God whose dream was to meet us face to face and then reconcile the hurts and sin, the mismanagement and abuse of the goodness God made, and to open the hearts of all people to new life centered in God.

Christmas is the focus of this gracious invasion of God into our lives. I wonder how many were in fact not ready for it, that first Christmas. Especially by the way he came: Not, as we know, through the plans of the Emperor, nor through the Emperor's puppet kings or politicians, nor through military might or manipulative domination. I wonder how many were prepared for this child, this nascent Prince of Peace, this challenger of the dominant culture. I wonder if you could even really be prepared.

We sometimes forget that we can't manipulate God or restrict God's presence to our personal schedule or preference, or only to those times when we have whipped up pious feelings. The Christmas story is filled with twists and turns and unpredictable events; shepherds caught off guard, magi who were mesmerized suddenly by a strange glowing star, and blatant interruptions during normal sleep in the middle of the night for both the believer and unbeliever.

I wonder whether we understand that our Lord comes to us in our time, in our situation and context. The Spirit who woke Joseph and then Herod's spouse from sleep with a startling message, who announced to Mary that she would give birth to a Holy Son who would save the world also wants Jesus to be re-born in us: Just where we are, right where we live, in the middle of our school studies, our grocery shopping, our daily work, our care for our family, our arguments with our neighbor, our kind deeds, our boredom and our fears. Jesus, the One whom we celebrate and adore, will be seeking you and me in the ordinary events of our life. Luther said something like this about Christmas: If the Infinite, could be embodied in a little baby, God can work through you!

Gather with your congregation this Christmas. Oh come, let us adore him, and like Mary and Joseph, like the Shepherds and Magi, let him work through us as well.

The meeting was called to order by council president George Smith.

### Secretary's Report:

A correction to the 'Update Long Range Planning Committee' from the November minutes to include Darlene Christensen and Dennis Hennesey on that committee was made. Motion was made to accept the corrected minutes of the November meeting by Mary Braun, seconded by Ron Haglund, and passed.

### Treasurer's Report:

Financial view and current month activity for November was presented by Mary Braun. Motion was made by Ron Haglund to accept the treasurer's report, seconded by Judie Birk and passed.

### Pastor's Report -November 16 to December 13, 2018

Merry Christmas! Holiday time is always busy for churches, even as we see folks starting to head off to warmer climates. Here a few highlights from the past month: Kozoil

- Lots of worship and music planning for Advent and Christmas worship. Special thanks to Jim Christensen and Mary Braun for all their help!
  - Contacted John Koziol for helping lead a "Lessons and Carols" worship service on Dec 30 – a good way for us to sing all our Christmas favorites
  - Participated in caroling last Sunday, helped bring some holiday cheer to folks; we also hosted an impromptu concert for the Memory Care wing at Lakesong in Onamia
- Continued to work with *Together Here,* our Synod's committee to help build understanding of and relationships with our Native American neighbors
  - Local Mille Lacs/Brainerd Lakes area group met at the Mille Lacs Indian Museum on Monday, 11/19, talked with Travis Zimmerman, site director and staffer Kaitlin Thompson about possibilities for educational opportunities
  - Attended another synod-wide group meeting on 11/20 in Duluth
- Among other fun activities, plan to write a fundraising letter for the Centennial Committee to send out around the first of the new year
- 5 pastoral care visits and calls
- All the usual odds and ends committees, choir and praise band, bible studies, etc
  - Thanks to some of our new Facebook page helpers – Darlene, Val, and Joanne; adding lots of nice photos and posts

### Old Business:

A motion to accept Dorothy Mundinger as a council member to fill the remaining term for Kathy Berland for this year was made by Jenny Schuett and seconded by Mary Braun and passed. Julie Swaggert is the new chairperson for the Personnel Committee with Ron Haglund as council rep. Additional committee members consist of Lee Forester, Pat Becker, Patti Smith and Mike Macioch. See the Personnel Committee report below.

Judie Birk reported on the Centennial Celebration committee. A few things noted were:

• A kickoff in January with opportunities to buy snowflake raffles (to support our Centennial celebration in August) and win a quilt (a monthly raffle is being planned with various prizes).

- A Snow Day event is being planned for Sunday, Jan. 20 (see info elsewhere in the Lifeline).
- A historical 2019 calendar for Bethesda is being printed and will be available for purchase for \$10. Unfortunately it will not be available by Christmas. But look for it right after the holiday.

Mary Braun reported that the Church Pictorial Directory is at the printer and will be delivered to the church early January.

Council discussed the action the Stewardship and Finance committee regarding an in-house audit. They need to gather the policies and procedures that exist from anyone that uses the church tax-exempt number. (See their report below). Dorothy Mundinger suggested that we create a form that whoever uses the tax number fill out.

### New Business:

Radio ad — KKIN Radio (94.3) has a special going to broadcast Christmas services/news. A motion was made by Mary Braun to try the 15 ad spots for \$90. Mary will send the information to the radio station.

A motion presented by personnel committee to pay our digital technician \$225 a month (a \$25/month increase) retroactive back to September 2018 was made by Ron Haglund and second by Mary Braun and passed.

George Smith talked about the Isle School Paw Pantry and the Isle Area Food Shelf. There's a real need for helpers, food and money. They have appreciated the support and donations given by Bethesda. Five quilts along with donations were given to the Paw Pantry and much appreciated. The Food Shelf is open on the first Tuesday and the fourth Thursday of the month. George will gather more information and give to the Mission and Evangelism Committee.

A council retreat was discussed and shelved to next month.

Committee Reports:

### Worship & Music:

Minutes from Dec. 7 meeting. Members present: Pastor James, Jim Christensen, Tom Christensen, Paula Spetz and Julie Swaggert. Pastor James opened the meeting with prayer

We discussed Sanctuary Banners and what (if any) additional Banners we could use. After looking at all of the Banners, we inventoried them and determined we could use more with Pentecost, Epiphany or general church year themes. The Banners are a great addition to the Sanctuary and there is interest in donating more Banners.

The Narrative Lectionary themes will be the Gospels beginning in January and other New Testament Books starting in May.

Musician John Koziol will be at Bethesda for the Sunday, December 30<sup>th</sup> Service. We will have a Service of Lessons and Carols. A stipend will be provided for John in addition to a free will offering.

We will be looking for Special Music and musicians for the Christmas to Easter time period where the Choir will not be singing. We welcome the congregation to suggest musicians or volunteer to be that special music!

Lent 2019 begins in March. Tentative plans will be for the Pastor exchange for Lenten Service (similar to last year) along with the Holden Evening Service music.

Stewardship & Finance Committee:

Meeting DECEMBER 10, 2018

1. Recommendation as presented by the personnel committee to pay Digital Technician \$225.00 a month retroactive back to September 2018.

2. Pastor James will check with some pastors in Isle regarding our discussion concerning homelessness

 Committee reviewed budget updates and will discuss more in detail at the January meeting.
Mary Vukelich reported on the in-house audit and the recommendation to start with policies and procedures. Discussion items included:

- Gathering the policies and procedures that exist at present from each committee and/or group that uses the church tax-exempt number. This includes WELCA and the Memorial Garden. Groups not having a policy and procedure need to develop a plan to follow in determining financial requests or expenditures. For example, stewardship will develop written procedures for how the church budget is prepared and recommended to the council. It will also include budget review procedures for the financial church year and financial requests and expenditures specific to Stewardship/finance as outlined in the policy and procedure document.
- A request will be made via the Lifeline and an announcement at church concerning what stewardship needs from groups regarding procedures they follow in financial matters. Groups will return their information to Donna Ansell (dansell25@gmail.com).
- Gather job descriptions for each of the committees and employees
- The in-house audit is an ongoing effort to bring clarity and a better understanding of how financial matters and expenditures are handled. We have not undertaken this venture before so for everyone, this is a learning process.

This is part of an annual "In-House" audit. Any committee or person using the church's tax exempt number for purchases needs to send Donna Ansell (dansell25@gmail.com) a copy of your policies and procedures. If you don't have anything written down, now is the time to start.

This is an ongoing effort to bring clarity and better understanding of our financial matters and how expenditures are handled. We have not undertaken this venture before, so please assist us in any way possible.

### **Operation Christmas Child**

During the month of January we will be collecting children's T-shirts for the shoe boxes that will be packed by the VBS kids in June. We need shirts for boys and girls of all sizes and colors. They can be placed in the large wrapped box in the narthex. Each month a different item will be collected.

### From the Parish Nurses

Just a reminder that we have an Automated External Defibrillator (AED) at the church in the narthex hanging on the south wall next to the double doors into the Fellowship Hall. An AED is a computerized device that delivers electrical shocks to a person in cardiac arrest when the ECG rhythm is one that is likely to respond to a shock. It can be used by a lay person until medical personnel arrive in an emergency. It is easy to use an AED. You turn on the device and there are clear concise voice prompts advising you exactly how to use the AED as well as perform CPR. So check out where the AED is located at church and go online and watch "2017 Hands-Only CPR Instructional Video" and "AED Demonstration" on YouTube. These one minute videos may help you save a life.

### What is an RMD?

Once you hit age 70<sup>1</sup>/<sub>2</sub>, the IRS requires you to start withdrawing from—and paying taxes on—most types of tax-advantaged retirement accounts. You will also need to take RMDs from any retirement accounts you inherit. In most cases, RMDs are treated as ordinary income for tax purposes.

# Can I donate my RMD to charity and avoid the taxes?

YES. These "qualified charitable distributions" (QCDs) will not be added to your taxable income for the year. *They must go directly to a charity* designated as qualified by the IRS. Making QCDs can be a great strategy for anyone who is charitably minded and does not need his or her full RMD. In many cases, it is more advantageous than taking the withdrawal and then donating it, because cash donations have deductibility limits. (Information taken from the

Making a QCD as opposed to a normal charitable gift has two main advantages. First, a QCD counts toward satisfying the individual's required minimum distribution for that year. Second, the distribution is excluded from the taxpayer's income. (Information taken from the website:
